

## Eligibility for Hearing Aid Coverage for Children Program (HACCP)

**Background:** On July 1, 2021 the state launched a new benefit for California children who are not eligible for Medi-Cal and/or California Children's Services Program (CCS) and live in a household with income up to 600% of the federal poverty level (FPL). The Hearing Aid Coverage for Children Program (HACCP) is available to children 0-20 without insurance or whose insurance does not cover hearing aids and related services or for those with plans with a coverage limit of \$1500 or less. Children can qualify for HACCP regardless of immigration status. HACCP will cover the following services: hearing aid(s) (including externally worn bone conduction hearing aids), earmolds, assistive listening devices, hearing aid supplies/accessories, hearing aid-related audiology services, and other related post-evaluation services. This table can help determine a child's potential eligibility based on family size and household income in 2023.
